Any member in good standing is eligible for nomination and election to any elective office. It is preferable that all nominees have previously served on the Board of Directors for at least one term.

Positions Not Eligible for Nominations

Chairman: As outlined in PPRA By-Laws, **Deirdre Hopkins**, current president, will assume the position of PPRA chairman.

President: As outlined in PPRA By-Laws, **London Faust**, president-elect, will assume the position of PPRA president.

Directors: Susan Buehler (Term to Expire 2021), Melissa Fordyce (Term to Expire 2021) and Hope Corse (Term to Expire 2022)

President-Elect

This individual will become president in the next operating year (2021-2022); a nominee must have served at least one year on the Executive Committee. This officer oversees the college relations and public affairs committees. Three-year term (President-Elect for 2020-2021; President for 2021-2022; Chairman for 2022-2023).

I Nominate:

Vice President for External Affairs

This officer oversees the Gold Medal, Hall of Fame and awards. One-year term.

I Nominate:

Vice President for Programs

This officer oversees all programming and social events. One-year term.

I Nominate:

Vice President for Membership

This officer oversees member recruitment, retention and mentoring. One-year term.

I Nominate:

Vice President for Communications

This officer oversees the blog, e-newsletter, publicity, website and social media committees. One-year term.

I Nominate:

Treasurer

The Treasurer oversees the sponsorship committees and is responsible for overseeing the association funds and financial records.

I Nominate:

Secretary

The Secretary oversees the community service committee and shall attend all meetings of the Board of Directors and shall assure that minutes are prepared and maintained for all meetings of the Board and the Members. One-year term.

I Nominate:

Directors (1) – Terms Expire 8/31/23

All PPRA members are eligible to serve as a Director. No less than 3 directors will be elected to the board. A Director’s term is no more than 3 years. As nearly as possible, an equal number of terms shall expire each year. For the 2020-2021 year, one director position is available.
